**PLEASE NOTE: DWI [Driving While Intoxicated] and Point surcharges [Accumulated Six (6) or more Points] are not eligible for deferral due to deployment for Military Duty.**

- I am hereby requesting deferral of my Texas Department of Public Safety – Driver Responsibility Program Surcharge accounts based on my deployment to a foreign station for military duty in the United States Armed Forces.
- I am enclosing a copy of my Deployment orders along with a copy of my ACTIVE Military ID. **(Note: Do not send originals; they will not be returned to you.)**
- I understand that this does not discharge my responsibility for payment of the eligible surcharges; only that the payments will not be due until my deployment has ended.
- I understand that I will be responsible for making minimum monthly payments to surcharges that are not eligible for deferral (DWI & Point surcharges) throughout my term of deployment overseas.
- I understand that upon my return to the United States from overseas deployment for military duty, I will have thirty (30) days to begin making minimum payments or payment-in-full to each of the deferred accounts.
- I understand that failure to comply with these requirements will result in the default of my surcharge accounts and suspension of my driver license.
- I understand that if I fail to provide a copy of my deployment orders, my application cannot be processed and that I will need to resubmit a new application with the required deployment orders. **(Note: You will receive an acknowledgement via standard USPS mail to your home address once your application has been reviewed. If you do not receive this within 30-days, please contact us. If you wish to be notified via email, please provide your email address in the space provided above.)**
